An individual who is currently licensed as an LPN in Kansas without restrictions and has completed the required non-nursing courses, if admitted to ESU Nursing, may be granted up to (12) nursing credit hours for the following courses: NU 308-Foundations of Professional Nursing; NU 310-Fundamentals of Nursing; NU 311-Fundamentals of Nursing Practicum; NU 306-Health Assessment; and NU 307-Health Assessment Lab. Eligibility for course credit will be based on successful completion of the validation process. The validation process consists of achieving a level2ontheATI (Assessment Technologies Institute) Fundamentals Exam and successful completion of a skills checkoff. The credits granted will be posted to the student's transcript after successful completion of the NU314- LPN Transition to Professional RN Role in the ESU Nursing program.
