b. Steve Catt provided the assessment knowledge share and his topic was collaborated efforts across the Communication and Theatre faculty in assessing the Public Speaking course. This course has multiple sections instructed by a different faculty. The course also fulfills the general education requirement for spoken and listening skills as defined in General Education Goal 1, Objective b, demonstrate effective communication skills in speaking and listening. The annual assessment uses student speech evaluation scored to the AAC&U Value rubric for Oral Communication. The rubric was altered by including

specific learning outcomes specific to each of the rubric's five dimensions. This created a direct alignment between the speech assignment and the rubric used for assessing the quality of student learning. This also allowed for students to understand exactly where their speaking performance was adequate and what areas could be improved upon. Based on the findings, faculty met to determine where change strategies would be employed for the upcoming semester. The faculty continue this process on an annual basis to continuously improve student learning.

### 5. Upcoming Year Assessment Plans

- a. Those programs with specialized accreditations will continue to assess as aligned with the directives of their accreditors.
- b. Those programs without specialized accreditations will use the curriculum map as a tool to prioritize assessments by selecting a capstone course(s) and assessing whether students are possessing the knowledge, skills, and dispositions appropriate to program level student learning outcomes. These assessments will identify where the strengths and weaknesses are for expected levels of student performance. In future years, faculty can focus assessment efforts on those courses that align with the areas identified as areas for improvement. We can have conversations about how this all fits together, engaging faculty early on to assist in the assessment efforts is key. Get this year's plan in place.

- a. An electronic document was provided to SLAC members that addresses guidelines for writing student learning outcomes to facilitate improvement in the presentation of student learning outcomes in syllabi. Chairs please check the syllabi for your departments to insure that outcomes statements are appropriately described.
