## MEHRING NEW DEAN OF THE TEACHERS COLLEGE

## Dr. Teresa A. Mehring

is the new dean of The Teachers College. Mehring previously was the associate dean. Mehring completed her undergraduate work at St. Mary College in Leavenworth, KS, receiving degrees in Psychology, Music Education, and Applied Music. She has a master's degree in Counseling Psychology from Southwest Missouri State University, as well as a master's degree in Special Education from the University of Kansas. Her Ph.D. in Special Education/Educational Psychology and Research also is from the University of Kansas.

Mehring began her career in education as a K-12 vocal and instrumental music teacher in Leavenworth, KS. She then worked as a psychologist and special education consultant in Glendive, Montana. Mehring joined the faculty at Emporia State University in 1981 in the Division of

Division, she was promoted to assistant dean in 1989, and associate dean in 1993.

Mehring sees many challenges and opportunities for growth facing The Teachers College as we approach the twenty-first century. century," Mehring

said. Increased

One of Mehring's favorite sayings is "TEAM — Together Everyone Achieves Miracles."

Another challenge for Mehring is to ensure that The Teachers College will maintain its tradition of excellence under her tutelage. "We've always been known for our leadership in education, whether it is in teacher preparation, or in preparing school psychologists and school counselors. We will continue to be leaders, not followers," she said.

Two changes currently being contemplated are a reorganization of the divisions within The Teachers College, and the development of a proposal for a doctoral degree within The Teachers College. These changes would allow The Teachers College to continue its tradition of excellence and to be more efficient and to better meet its constituent's needs. The Teachers College also is developing a five-year strategic plan to take it into the twentyfirst century.

## DEAN'S COMMENTS

### When

I joined the faculty in the Division of Psychology and Special Education in 1981, I made a verbal commitment to

the division chair that I would remain at Emporia State for two years. thinking that I would establish myself in higher education, then move on to "bigger and better opportunities." Well, it is now fifteen years later, and not only am I still at ESU, but I now have the opportunity to lead The Teachers College. In my travels and interactions with higher education colleagues throughout the country, I have personally visited, read, and heard about "bigger" institutions. I also have gleaned much information about programs of distinction both within our state and nationally. Few rival the traditions of excellence for which The Teachers College has become known!

I am proud to be a faculty member and now dean of The Teachers College at Emporia State University! I have the privilege of working with not only a dedicated, but extremely knowledgeable and talented faculty. Their accomplishments (publications, grants, and leadership in state, regional, and national organizations) grow by leaps and bounds each year! Equally important to The Teachers College team are the numerous staff members who are the "heart and soul" of our daily operations—the individuals who often give the initial and sometimes most lingering impression of the university and The Teachers College. Another source of pride is our students. They are earnest, genuinely interested in learning, and committed to becoming professionals who are critical thinkers, creative planners, and effective practitioners. One of the most important groups I have the privilege of interacting with on almost a daily basis is alums of The Teacher College. As I visit agencies, elementary and secondary schools or

attend professional meetings
throughout the state and nation, I
invariably run into individuals who

I have yet to interact with an alum
who wasn't proud to be an ESU
graduate! It is that pride, echoed by
the individuals who have experienced
the quality of what The Teachers
College has to offer, as well as the key
strengths of The Teachers College
"team" that has prompted me to
remain at Emporia State University
for the past fifteen years!

Our future bodes many "challenges." Within the college, we are examining the possible redesign of three divisions—Teacher Education, Early Childhood, and Educational Administration. Accreditation is continually on our minds . . . our Art Therapy program recently successfully completed the accreditation process. We're now preparing in earnest for accreditation reviews from the Kansas State Board of Education, National Council for Accreditation of Teacher Education (NCATE), The National Association of School Psychologists, and the Council for Accreditation of Counseling and Related Educational Programs (CACREP)! Four additional Professional Development Schools will open next fall-two in Emporia and two in Olathe. We're also completing a long range plan for The Teachers College and investigating the feasibility of our first doctoral program. At the state level, we are keeping close tabs on the redesign and licensure proposal for teachers and other school practitioners. The Kansas Legislature is examining the manner in which funding is allocated to the Regents' institutions and The Kansas Board of Regents has implemented a multi-year initiative called VISION 2020 which will likely result in universities "doing more with less." To say the least, we have a full agenda to respond to within coming months.

I've always been a firm believer that in every challenge, there also is "opportunity." I have no doubt that The Teachers College team (faculty, staff, students, and alums) will proactively meet the challenges delineated above and numerous others as they are added to our agenda. We will aggressively chart a course which continues our tradition of excellence!

the largest division in The Teachers College, the Division of Teacher Education is

charged with the task of preparing preservice and in-service teachers for the challenging tasks involved in meeting the needs of diverse elementary and secondary school students. To meet this responsibility, the division has raised admission standards and made changes in the undergraduate programs offered by the division. This fall, the first students began the recently approved master's degree program in Instructional Design and Technology and revisions are under way in the other graduate programs offered by the division.

Despite increased admission requirements for undergraduate students, enrollments in both elementary and secondary undergraduate programs remain strong. This fall, undergraduate elementary education students will develop professional portfolios for the first time using criteria developed by the elementary education faculty. Added to the other rigorous assessments made of students in the elementary program, portfolios will offer an opportunity for additional dialogue between students and faculty and also will offer opportunities for students to provide feedback to each other.

Since the fall of 1993, elementary education students have had the option of participating in a Professional Development School in two Olathe elementary schools. Directed by Dr. Jean Morrow, the Professional Development School is a year-long program that involves the students in classroom experiences throughout their methods and students teaching semesters in place of traditional methods classes offered on campus.

Research on this innovative program supports the Professional Development School model of delivery. The Professional Development School program will remain in Olathe and will expand to include two new Professional Development Schools in Emporia (USD 253). They will be housed at Maynard and William Allen White Elementary Schools next fall.

Beginning this school year, graduate students began to enroll in the division's new Instructional Design and Technology master's degree program. This program is designed for practicing teachers and others who wish to utilize technology to improve instructional programs. To support this new program, improvements have been made in The Teachers College computer lab and a new media lab was opened during the fall of 1994. A major addition to the media lab occurred in December of 1995, which added space and equipment for both undergraduate and graduate student use.

The Division of Teacher Education is actively involved in bringing the latest technology and methods to undergraduate and graduate students. Innovation, however, requires appropriate funding to update technology and materials used in classes. Projected cutbacks in federal and state funding for higher education threaten the positive efforts made by the division. Students, alumni, and parents are encouraged to make legislators aware of their concerns about proposed cuts in higher education and public school funding. The generous financial support of alumni also is essential to continuing the excellence that characterizes our programs.

The Teacher Education Division offers outstanding opportunities for undergraduate and graduate students who wish to make a difference in elementary and secondary classrooms. If we can provide further
