

# ESU lands \$3.8 million for ESL teacher education programs

The U.S. Department of Education has awarded two ESU faculty \$3.8 million to establish English as a Second Language training programs in 14 Kansas school districts. Drs. Cynthia Seguin and Abdelilah Sehlaoui received the awards in the form of three grants over five years. The grants will provide tuition for teachers working toward a 15-hour ESL certificate. Teachers in the program will also receive a \$1,000 stipend or a laptop computer. Classes will cover multicultural education, language assessment and evaluation, cultural awareness, and linguistics. Professors will use a combination of online classes and on-site workshops in the course of their instruction.

# ESU's elementary education program expanding locally and regionally

Emporia State's department of early childhood/elementary teacher education is forming new partnerships that will impact its teacher education program.

The elementary education Professional Development School program added a third district to the program this fall. Americus Elementary School, in North Lyon County school district, joined elementary schools in Olathe and Emporia as PDS sites. All elementary education majors will complete their senior year in a PDS school beginning with the 2003-04 academic year.

Earlier this fall, members of the National State Teachers of the Year executive board visited the PDS program at Americus School. After their visit, Edna Rogers, president of the National State Teachers of the Year organization, wrote, "The Professional Development School program is a great model. I wish other colleges and universities could visit and see how effective it is."

# Academy for Future Teachers: A Sound Investment in Our Children

The 2003 Future Teacher Academy at Emporia State is tentatively scheduled for July 6-10. But while planning must get underway now, a supplemental funding source has yet to be identified to make next summer's academy a reality.

Sponsored by The Teachers College and directed by the Jones Institute for Educational Excellence, the academy has graduated nearly 700 of Kansas' brightest high school juniors and seniors over 14 summers. Since 1989, when the first academy had the honor of receiving the AASCU Christa McAuliffe Showcase for Excellence Award, the Future Teacher Academy at ESU has provided select students with the opportunity to learn more about the challenges and rewards of teaching and has become recognized as an established and highly respected training opportunity for students throughout the state of Kansas.

"This is an excellent program for recruiting our top high school students into the teaching

Directors of national and state projects housed in JIEE presented updated information to Kansas' Senate Legislative Education Planning Committee on October 11. # Teachers achieve national certification

Thirty-seven Kansas teachers achieved National Board Certification in 2002 according to an announcement in November by the National Board for Professional Teaching Standards (NBPTS) in Arlington, Virginia. That brings the total of National Board Certified Teachers (NBCTs) in Kansas to 109.

The number of NBCTs in Kansas has increased every year since 1995, the year that ESU permanently established the Great Plains Center for National Teacher Certification and expanded its program of professional support for National Board candidates. It is the first and only program of professional support in Kansas for National Board candidates that has been recognized and approved by both the NBPTS and the Kansas Board of Regents.

"Emporia State began as a field-test site for NBPTS in 1993," said Linda Hazel, director of the Great Plains Center housed in the Jones Institute for Educational Excellence. "When field testing ended in 1995, we knew it was important to continue offering professional mentoring and support for teachers going through the NBC process because on-going feedback from our candidates indicated that for nearly all of them, going through the process had made them better teachers whether or not they had achieved National Board Certification. That was powerful."

Teachers who become candidates for national certification undergo a rigorous and extensive assessment of their classroom practice that includes a major focus on their ability to impact and sustain student learning. At the end of the process, candidates are assessed by a national panel of their peers.

Achieving National Board Certification is extremely difficult, said Hazel, In fact, the national certification rate is typically only around 50%. Kansas candidates have a certification rate that is consistently above the national average, sometimes by as much as 21 percentage points.

Most of the candidates in Kansas who have gone through the process and achieved certification have participated in ESU's program of professional support throughout their candidacy, generally one to three years. Emporia States program is provided at no cost for candidates throughout Kansas.

profession when they might be sitting on the fence trying to make that decision," said Scott Waters, a professor in The Teachers College and director of the academy. "It's also a proven tool for recruiting those same students into our top-rated teacher education program where we know they'll get the well-rounded, quality training necessary for becoming competent teachers."
